Alex Kuhner	8 Quarter Mile Rd	What was the specific percent of teachers who said they were comfortable with distance learning for each school level? Saying it was "a majority" could mean 51%, which would mean 49% are not and we need to improve the situation for that group.
Alex Kuhner	8 Quarter Mile Rd	Comment: The system to manage attendance, assignments, schedules, grades, etc, needs to be a single platform with a standard use of each field. You can't have one teacher adding and assignment that says "Monday 5/15" while another writes a full sentence in the subject, or one teacher putting the date as the day you should do the work while another puts the date and time it must be turned in by (which is the correct way). There is no perfect platform, all of them can work, but poor implementations will ruin even the best software.
