		Regarding the proposed changes to 5th grade math, there is also research that shows that students who are not challenged in class become demotivated, also lose persevere and can be distracting in class. Was that research taken into consideration?
		Also it's worth mentioning that if students are grouped within a class for differentiation strategies, students will still know who is working on the high ceiling tasks vs the low floor tasks.
		In addition, have the teachers really been given the tools and time to explore and practice with new differentiation strategies? Particularly with the closure of school, there currently is, as there should be, significant focus on how to improve and enhance distance learning. It doesn't seem like there has been enough time for the teachers to really get comfortable with these new tools and strategies and this is the key to supporting the deleveling.
