Matthew Heiser	6 Smokey Lane	Part 1 of 3: Regarding the Equity Study proposed by the Board, could the Board elaborate on the specific reasons this study is needed? As the Board is aware, one of the issues with studies such as these is that they are often used to reach a particular result and to make recommendations so as to justify the time and expense spent. To what extent will the Board be addressing, in advance, the content and methods for the study as well as the definition of "Equity" used, so as to avoid commissioning a study that itself has implicit biases and serves only to push one idea of Equity. A cursory review of the NYU Metropolitan Center's website shows an organization with a strong leftist ideological bent

Matthew Heiser	6 Smokey Lane	Part 2 of 3: While they might consider, for example, the effect of a lack of racial diversity among Westport faculty on minority students, they might not consider the effects of the lack of male elementary school teachers on the 50% of the elementary students who are boys, or the ideological makeup of the teachers themselves and how that affects "Equity". They will likely consider leftist concepts of equity and fairness, but not moderate or conservative ones, and they are certainly unlikely to broach the topic as to whether equity and fairness should always be pursued to the exclusion of other important values. Has the Board asked them these questions? Will it?
Matthew Heiser	6 Smokey Lane	Part 3 of 3: One way to address this might be for the Democrats and the Republicans on the Board to each appoint someone to oversee the study in order to ensure that it at least attempts to be ideologically neutral. In that way, the Board can ensure that the study is using methods, rubrics and definitions that strike a balance, and isn't just peddling a viewpoint that is rather obvious from the Metropolitan Center's website.

Others tonight have mentioned the anecdotes brought forward by students of color via essays and letters publicizing specific instances of racism during the school day. Some students have taken the additional steps of testifying publicly in various town meetings about these incidents in a deeply personal way. The need for this data is clear. I hope the study will be completed as soon as possible. I also request that any written report is shared in its entirety with the RTM's Education Committee.
