Be it further resolved, that the Board of Education authorizes the Superintendent of Schools to fund the aforementioned purchase by temporarily suspending the purchase of budget items that the Superintendent of Schools deems not required for the first three months of the FY 2020-2021 school year.

Grant to Chief Financial Officer of Emergency Purchasing Power and Waiver of Competitive Bidding Requirements for Personal Protective Equipment
