Provided below for Board consideration is an overview of the meeting agenda items for December 6, 2021. The meeting will be held in-person.

Discussion

1. Health Update

As I mentioned to the school community in a message Wednesday evening, less than one month ago we experienced Covid infection rates that hovered at levels we had not seen since May. Since then, we have experienced an increase in infections in the region and the forecasting of the Omicron variant. Generally speaking, we will continue to consider our mitigating measures in 4-6 week increments.

Supervisor of Health Services, Sue Levasseur, will report the recent trends and she and I will discuss the vaccination efforts in the community. In addition, we will share some of the changes to our mitigating measures including: weekly serial testing, school performances/concerts, vaccination requirements for school visitors, and our "screen and stay" quarantine approach.

2. <u>S/L/A/M Enrollment Projections</u>

Enrollment projections are a key driver in the short, and long-term, planning of the district. Enrollment impacts the overall budget, as well as programming, staffing, facilities master planning, among other key components, of the district.

Last month, the former Board was presented with enrollment projections from the New England School Development Council (NESDEC). The presentation is available for our new Board members on our website. We can also provide this information to new Board members through my office if requested.

With the uncertainty of enrollment projections as a result of Covid, the administration has recommended seeking enrollment projections from two separate agencies again this year. The December 6 presentation and analysis will be provided by Mike Zuba (formerly of Milone and MacBroom) and his firm, SLAM Collaborative. Milone and MacBroom, a name familiar to Board members and the community, has joined with SLR consulting, and is no longer developing enrollment projections. This second round of projections should serve the Board well in the upcoming 2022-2023 operating budget deliberations. As reported earlier this year, the flight of families into Connecticut was experienced most significantly in Westport. Our schools are a primary draw for young families. These projections are a useful tool in planning and budgeting. That said, the fluidity of movement of families, and the unknown factors (i.e. the pandemic) make the task of projections more challenging than ever before.

3. <u>FY 2022 Preliminary Budget Discussions with Board of Finance, RTM Education Chair, and Finance Committee</u> <u>Chair</u>

Each year the Chairs of the Board of Finance, RTM Education Committee, and RTM Finance Committee are provided an opportunity to address the Board of Education prior to the deliberations of the Board's operating budget. This item is an annual practice which initiates the budget process through a collaborative discussion.

In addition to enrollment projections, the information provided by the town Boards should serve the Board of Education well in the upcoming budget deliberations.

4. Town of Westport ARPA Funds

This item is a follow up from prior Board discussions. Although it is only a discussion item for December 6, Board action will need to be taken on December 20 to advance this request.

The town has been granted \$8.4 million in federal American Rescue Plan Act (ARPA) funds. ARPA provides \$350 billion nationally in funding for state and local governments.

Following a presentation to the Board of Finance by the prior First Selectman, the Board of Finance asked the Board of Education for input regarding the possible use of a portion of these town funds for our schools. The Board of Education has already received Covid relief funds which were included in the offset of the 2021-2022 operating budget. The ARPA funds are municipal funds, yet the town has requested the Board of Education's input for possible use in our schools.

In response to the Board of Finance request to the Board of Education, the administrative team researched possible uses and cost estimates. Assistant Superintendent for Curriculum and Instruction, Dr. Anthony Buono, has worked with members of the administrative team, as well as potential vendors, to get cost estimates of these recommended projects. This will be Dr. Buono's second presentation to the Board in anticipation of a Board vote on December 20 for a recommendation to the Board of Finance.

The attached slide deck (forthcoming Friday) outlines the following projects presented to the Board for funding consideration:

- the development of outdoor learning centers at our elementary schools which will make Westport the first district in the state to have outdoor learning centers at each of its elementary schools
- the addition of playground equipment for the middle schools,
- high and low ropes courses for our high school to support social and emotional development through curricular programs that create instructional "adventures" and opportunities for students to authentically problem-solve, face the unexpected, and develop collaboration and leadership skills

Again, this is a discussion topic only for the December 6 meeting. Board action will be asked for the December 20 meeting.

5. <u>Proposed Course Proposals</u>

The administration is proposing two new courses for next year. Both are being proposed in order to enhance and complement current program offerings and to provide students with opportunities and content that is not currently being offered. Below is additional information on each of the courses.

AP Computer Science A

AP Computer Science A is a well established AP course that many current software engineers and computer scientists took when they were in high school. While Staples currently offers a wide range of computer science/programming courses, we are the exception in the area for not offering AP Computer Science A. Inclusion of this course in the Staples computer offerings will round out our robust offerings and provide an avenue for students to explore an ever expanding area of STEM careers before they matriculate to university.

Popular Music & Diversity in American Society

The Staples Music Department is excited to propose a new course, "Popular Music & Diversity in American Society" This is a new UConn Early College Experience (ECE) course that aligns with two of the department goals offering more non-performance based and honors/AP-level courses. The class aims to make connections between modern society and popular music over the past 100+ years using primary sources to analyze and study music from the viewpoint of contemporary American society, exploring issues of class, gender, race, and resistance.

6. Proposed Board of Education Meeting Dates 2022-2023

The attached calendar lists the proposed Board of Education meeting dates for the 2022-2023 school year. You will notice the extra meeting dates in January to accommodate for the budget deliberations.

Discussion /Action

1. Building Committee for the Staples High School Roof Replacement Project

As was shared at the last Board meeting, we were recently informed, after submitting the state grant application for reimbursement, that a formal building committee will need to be assigned and formally approved to advance the grant application for the Staples roof project. The town maintains a standing building committee, the Westport Public Site and Building Commission. It is the recommendation of the administration that the Board of Education take action to request that the RTM designate the Westport Public Site and Building Commission serve as the formal building committee for the Staples roof project. After review with the town attorney, it is understood that this commission will satisfy this state requirement in order to be eligible for reimbursement grant funds for the project. Given the narrow and targeted nature of this project (i.e. a roof project), I recommend this action. If this project were of a broader scale (e.g. renovation of a school building), then I would recommend that the Board appoint an independent building committee.

2. Gifts

At a prior Board meeting, the Board was asked to approve funds donated by booster clubs to cover the costs of the addition of assistant coaches in specific programs. Over the years, in order to accommodate the considerable athletic student body,, a number of athletic support clubs have provided funds to cover the costs of additional coaches in our programs. These positions, largely assistant coaches, are to help supplement our programs due to either an increase in participation rates, or needed supervision to maintain appropriate levels of safety. This process must be done through formal Board of Education action in accepting donations.

The Staples Athletic Department is requesting that the Board formally accept the gift of the winter coaching stipends from the Staples Boys Basketball Association and the Boys Indoor Track Booster Club to cover the costs of 1 assistant coach for each of these programs.



§ C21-1. - Composition and Appointment.

The Public Site and Building Commission shall consist of 9 members, who shall be electors of the Town, appointed by the First Selectman and confirmed by the Representative Town Meeting. Such members shall serve for four-year terms and until their successors are appointed and have taken office. In 1987, 5 members shall be appointed and 4 members shall be appointed in 1988 and thereafter alternately.

§ C21-2. - Powers and Duties.

The Public Site and Building Commission shall manage and have control of those approved building projects specifically assigned to it by the First Selectman and may assist, upon the First Selectman's request, in planning all other building projects of the Town of Westport and in supervision of construction of such projects. Contracts in connection with all building projects, whether or not assigned to the Public Site and Building Commission and including but not limited to school building projects, shall be authorized by the Board of Selectmen. The Public Site and Building Commission may request the First Selectman to appoint an engineer to work at its direction. Unless otherwise expressly designated by the RTM with the concurrence of the First Selectman, the Public Site and Building Commission shall be designated as the school building committee as that term is defined by the General Statutes.
