No lanyard no game attendance.</li><li>- All parents must wear face masks and must maintain social distance. We can even put ribbons 7 feet apart along the fence so parents will know where to stand. Also, since soccer and field hockey will not be played at the same time, some of the parents can stand along the edge of the soccer field.</li><li>- No congregating before or after games. Upon completion of games all parents back away to the parking lot.</li><li>- Of course, there are always be booster club parents at games and can help assist that all this is being done safely.</li><li>- These kinds of numbers for an outdoor event are way below what the CT State has set as safe guidelines.</li></ul> |
